Bridging the Atlantic has been one of the most significant undertakings over the last six centuries, with implications at the global level. The Atlantic has long served as a catalyst for exchange, influence, and transformation. From early navigation and colonial histories to contemporary challenges such as climate change, migration, and transatlantic trade, the ocean remains a dynamic space of interaction. The birthplace of the first wave of globalization, with the maritime discoveries of the 15th century, it is also at the heart of the second wave of globalization in the 20th century, through the alliance between north Atlantic powers, on both sides of the Ocean. As the hegemonic nature of North Atlantic West is increasingly challenged, the view of the Atlantic as a connector remerges, linking both north and south margins to other oceanic spaces and societies. This conference aims to examine what bridges culture, politics and knowledge across the Atlantic, over time and how these processes continue to shape our views of this Ocean region.

The sixth edition of the LPAZ Forum will convene in Santa Maria Island – Azores, Portugal, from September 1st to 3rd, 2025, under the theme "Atlantic Bridges - Culture, Politics and Knowledge." This three-day event is organized by the LPAZ Association, in collaboration with the Center for International Studies of Iscte-Instituto Universitário de Lisboa (CEI-Iscte), the Faculty of Economics of the University of Coimbra (FEUC), the Center for Humanistic Studies of the University of the Azores (CEHu), the Atlantic Centre, the Transatlantic Studies Association (TSA), the Portuguese Association of French Studies (APEF), the Margarida Losa Institute for Comparative Literature (ILCML), and CHAM Açores - Center for the Humanities (Nova/UAc), with the support of the Regional
